Know All Persons By These Presents, That: _____

as **PRINCIPAL** organized and existing under the laws of the State of _____,

and _____, a surety company organized and existing under

the laws of the State of _____ and authorized to transact business in the State of Wyoming, as **SURETY**, are held and firmly bound unto the **STATE OF WYOMING and to any party who may be a "claimant" within the meaning of W.S. 33-11-108**, in the sum of **TEN THOUSAND DOLLARS (\$10,000)**, lawful money of the United States, for the payment of which we bind ourselves, our heirs, legal representatives, successors and assigns, jointly and severally, firmly by these presents.

Whereas, prior to receiving a Collection Agency license under the Wyoming Collection Agency Act, W.S. 33-11-101 through 33-11-116 (the "Act"), authorizing PRINCIPAL to engage in the business of a collection agency as provided in and in accordance with the Act and the Rules and Regulations (the "Regulations") of the Collection Agency Board of the State of Wyoming (the "Board"), PRINCIPAL is required to file and thereafter maintain with the Board a surety bond as required by the Act, which requirement this Surety Bond is intended to satisfy; and

Whereas, PRINCIPAL expects to enter into agreements to provide services as a collection agent for such claimants.

Now, Therefore: PRINCIPAL, as a licensee under the Act, shall pay and turn over to or for the use of any claimant from whom any claim is taken or received for collection, the proceeds of such collection less the charges for collection in accordance with the terms of the agreement made by PRINCIPAL and the claimant,

And this Surety Bond shall cover all debts placed with PRINCIPAL for collection and shall be and remain in full force and effect on and after the _____ day of _____, 20____, and any action on this Surety Bond shall be governed by Wyoming law.
